Rose Houses

People USA created and operates Rose Houses. The 1st peer-run crisis respites, or short-term crisis residence in New York State. Currently, there are 4 houses serving 6 New York Counties.

We have helped open 42 Crisis Respites using the Rose House model in Alaska, California, Georgia, Massachusetts, Michigan, Minnesota, Nebraska, New Jersey, New York, North Carolina, Pennsylvania, Vermont, Washington, Wisconsin, and Europe.

We are currently developing over 5 more new Rose Houses across the U.S. and in the Netherlands. New York State based its Residential Crisis Support regulations, guidelines, licensure, and billing rates on People USA's model.

About the Model: Rose Houses are 24/7 home-like alternatives to using hospital psych. In ERs and inpatient units, where guests can work with highly skilled and trained staff on a full, customizable menu of services designed to help them understand, manage, and overcome the underlying causes of their crises, now and in the future.

Crisis Stabilization Centers


People USA created and operates the Dutchess County Stabilization Center, the 1st Crisis Stabilization Center in the Northeastern United States, and the 1st peer-led in the world. We are currently developing our 2nd and 3rd in the New York Counties area. New York State based its new Crisis Stabilization Center regulations, guidelines, licensure, and billing rates on People USA's model.

About the Model: People USA's Crisis Stabilization Centers are a 24/7 community crisis response hub. Where people of all ages, adults, children, and families can connect immediately with an array of healthcare professionals and providers, to address any mental health, addiction, or social determinant of health needs. The service is 100% voluntary, where people can walk in on their own or be brought by law enforcement or emergency service personnel on crisis intervention calls and can stay up to 23.59 hours.



Law Enforcement CIT Training


People USA has organized and provided Crisis Intervention Team (CIT) training to law enforcement in serval counties in New York State, and in 2022 trained 29 officers.

CIT Training is designed to equip responding officers with the skills, knowledge, and community connections. The five main goals of this program are to be able to engage safely and effectively with people in crisis, improve the overall safety of such interactions for all parties included, divert people from the criminal justice system whenever possible, reduce repeat Emotionally Disturbed Person (EDP) calls, and link people in need to the best local services, supports, and resources.
